

Base: Slightly texture maintenance-free surface allows for easy cleaning.

**Top:** 45 lb. density M3 Grade particle board with embedded t-nuts for mechanically attaching top to base with a secure steel-to-steel connection. Made in the U.S.A.

### **Material**

**Base:** Rotationally molded, specially formulated, fire-retardant, high-impact polyethylene with ultraviolet stabilizers to reduce fading. Chemically resistant to blood, vinegar, urine, feces, salt solution or chlorine solution. Premium material is fully compounded for superior color, fire retardancy and quality assurance. Unit is filled with rigid structurally polyurethane foam for increased durability and sound absorption.

**Top:** Decorative high-pressure laminate sealed with a specially fornulated, highly durable molded edge. edge is radiused for safety and pressure fused to the top, rendeing it permanently non-removable and highly sanitary.
