



#### Fabrication

Slightly texture maintenance-free surface allows for easy cleaning. Made in the U.S.A.

#### Material

Rotationally molded, specially formulated, fire-retardant, high-impact polyethylene with ultraviolet stabilizers to reduce fading. Chemically resistant to blood, vinegar, urine, feces, salt solution or chlorine solution. Premium material is fully compounded for superior color, fire retardancy and quality assurance. Unit is filled with rigid structuraly polyurethane foam for increased durability and sound absorption.

#### Installation

Wedge anchors and 3/8"" bolts required for permanently attaching to floor. Anchors and bolts not supplied. Groove along underside edge for caulk application (caulk not supplied.)

## Warranty

5-year limited replacement warranty. To maintain product integrity, products placed in storage prior to installation should be held in a climatecontrolled area similar to the room where the product will be used. Behavioral Safety Products also recommends that any Attenda products shipped via ocean container maintain a temperature of 70–75°F with a relative humidity of 35°.
